Only the children since the age of 6 years till 15 years (i.e. till the day preceding the 15th birthday) are entitled to a reduced fare. Since 10 years of the child's age it is necessary to prove the child's age by means of a forwarder card, valid passport or a pupil card.

The reduced time ticket can be granted to the following persons:

- children since 6 years till the completion of the 15th year (i.e. till the day preceding the 15th birthday) in connection with the forwarder card. As regards the one-day-ticket, the children aged 10 till 15 can prove their identity by means a valid passport or a pupil card.
- pupils and students – except for the wage-earners till 26 years in connection with the forwarder card. As regards the one-day-ticket, the pupil can prove his claim for a reduction by means of any other card.
- pensioners – having a full disability and old-age pensions and the persons since 70 years in connection with the forwarder card. As regards the one-day ticket, the person over 70 years can prove his claim to a reduction by means of his identity card.
- workers of the organization Charity in connection with the forwarder card

Only the citizens over 70 years can ride with a reduced non-transferable ticket **Senior Passport** in connection with a card that is issued by the forwarder after presentation of their identity cards and their actual photographs.

Only the following persons can ride with the non-transferable yearly ticket **Riding Passport**:

- holders of the gold Janského plaketa in connection with the card issued by the forwarder after presentation of their identity cards and the holder's card of Janská plaketa and their actual photographs.
- district nurses and care service nurses of the Community Care Service of Olomouc in connection with the card issued by the forwarder and after presentation of the employee's card
- pensioners – holders of valid cards issued by Military Association of Rehabilitated Persons of the Czech Republic, holders of certificates according to § 8 of the Law No. 255/1946 Sb. concerning the members of the Czechoslovak Army abroad and about some other participants of the national

struggle for liberation, as well as the decree according to § 29 of the Law No. 87/1991 concerning out-of-court rehabilitations, acknowledgment of the military administration for the applicants for an out-of-court rehabilitation according to the Law No. 87/1991 in connection with the card issued by the forwarder.

Free of Charge Transport in the Zone 71:

- a) children up to 6 years
- b) representatives of the state power and some state authorities according to a special legal rule.
- c) holders of the “ZTP” cards and holders of the “ZTP/P” cards, incl. their guides or a dog of a blind person, or an invalid chair .
- d) workers of the state professional supervisory organ in transport.

Negotiated Fare in the Zone 71:

- a) members of the Police of the Czech Republic , incl. their luggage and dogs in connection with their official badges and identity cards.
- b) members of the Military Police of the Czech Republic in Olomouc, incl. their luggage and dogs in connection with their official badges and identity cards.
- c) Policemen of the Town Police of Olomouc wearing an uniform in course of their duty, incl. luggage and dogs in connection with their official badges.
- d) employees of MmOI in working days having a transferable ticket and employee's card and the members of the Board of Representatives of the Town Olomouc having the representative's cards.
- e) holders of issued parking ticket from the underground parking place near the main station of the Czech Republic valid for 60 minutes from the time of issuing.
- f) holders of the “Olomouc Region Card” at the time of its validity.

Transport of Luggage and Animals – Freight Charge:

Payment of the freight charge amounting to the reduced fare for a particular run in the zone 71 applies for transfer of the following objects:

- a) pram without a baby ,
- b) luggage over the sizes of 30 x 40 x 60 cm,
- c) luggage of bar shapes, with diameter over 10 cm or longer than 150 cm
- d) luggage of plate shape over the sizes of 80 x 100 cm,
- e) luggage whose weight does not exceed 25 kg,
- f) dog without a box.

The following objects can be transported free of charge in the zone 71:

- a) luggage whose sizes or weights do not exceed the above values,
- b) pram with a baby,
- c) one pair of skis with sticks,
- d) one funeral wreath.

How to return the fare:

The passenger is entitled to get back the fare paid for non-used or only partially used month's and quarterly tickets for the zone 71 or for a combination with this zone, except for pupil tickets, for reasons caused by the passenger. The

passenger will be given an amount for all non-used days, reduced by a handling fee amounting to 10 per cent of the total value of the returned time ticket.

Only the holder of the returned ticket or the person who presents the valid identity card of the holder of the returned ticket, or the statutory deputy for the holder can make a claim for return of the fare, namely after presentation of his valid identity card. The passenger makes a claim at the forwarder who issued the riding document. The claim for the return of the fare cannot be made retroactively.

Issue of Duplicates:

Should a loss, theft or card damage issued by the forwarder or the time ticket be announced, the forwarder issues a duplicate of the time ticket card amounting to 2,- CZK and the duplicate of the time ticket amounting to 50,- CZK. This statement applies only to the zone 71 and for the tickets issued by the forwarder Dopravní podniku města Olomouce a.s. The duplicate of the time ticket can be issued only for month's, quarterly, half-yearly and yearly tickets. The issue of the duplicate of the time ticket can be made only once in a calendar year.
